Terms and conditions

March 2010

Please read the following terms and conditions before completing and signing the attached application form.

1. To be eligible for a rebate, you must meet the following conditions:

- a. The dual flush toilet must be bought new and installed on or after 15 January 2010 and on or before 30 June 2011 or any earlier ending date specified on Sydney Water's website.
- b. Sydney Water will only pay one rebate for each property to a maximum of \$200.
- c. The dual flush toilet must be installed at a residential property that has an authorised or approved connection to a water main owned by Sydney Water.
- d. The dual flush toilet suite must have a water efficiency rating of at least four stars under the WELS scheme on the date of purchase. This requirement applies to each of the cistern and the pan, even if they are bought as separate components. For an up-to-date list of toilets that qualify in this regard, please refer to the WELS database found at www.waterrating.gov.au
- e. The dual flush toilet must replace an existing, functioning single flush toilet suite and must include both the cistern and pan. Rebates are not available for replacing the cistern only.
- f. The dual flush toilet must be installed by a licensed plumber and the plumber must complete sections 4 and 5 of the application form.
- g. The installed dual flush toilet must meet all applicable standards, building codes, and Sydney Water and local council requirements.
- h. Sydney Water must be given an original tax invoice(s) or receipt(s) stating:
 - i. date and place of purchase
 - ii. brand, model and trap type of the dual flush toilet, specifying the model of both cistern and pan if unmatched
 - iii. the receipt number
 - iv. the ABN of each store, plumbing company or plumber that you bought your dual flush toilet from
 - v. that payment has been made in full with a combined purchase price of the toilet suite and installation, labour and materials of at least \$200
 - vi. the date that the dual flush toilet was installed at the residential property indicated on the rebate application form
 - vii. the licence number of the plumber or plumbing company that installed your dual flush
- i. Dual flush toilets bought through interest free loans are not eligible for a rebate until all payments to the loan provided have been made in full and the submitted receipt shows a zero balance owing on the loan.
- j. Where the dual flush toilet has been on lay-by, the first payment date must be after 15 January 2010 and the final payment must be made before 30 June 2011 or any earlier date noted on Sydney Water's website.



- k. The dual flush toilet must have a minimum 12 month manufacturer's warranty.
- I. If you are required to install a dual flush toilet to comply with the requirements of a BASIX certificate, you are not eligible for a rebate.
- m. Dual flush toilets installed as part of Sydney Water's Toilet Replacement Service are not eligible for this rebate.
- n. Dual flush toilet rebate applications must be submitted to Sydney Water by 30 September 2011 or any earlier date noted on Sydney Water's website.

2. In addition, you agree to the following:

- a. Sydney Water reserves the right to conduct inspections of dual flush toilets that have been submitted for a rebate and you consent to Sydney Water entering your property for such purposes.
- b. Rebate payments will be by cheque or EFT and made payable to the rebate applicant(s) stated on the application form.
- c. Sydney Water will not be responsible for items lost or delayed in the mail, or if any remittance is delayed due to incorrect rebate applications.
- d. Although every effort will be made to return original receipts, Sydney Water will not be held responsible for failure to return original receipts. Applicants are advised to retain a copy of their receipt for warranty purposes.
- e. Sydney Water does not guarantee the performance or quality of the toilet suite or plumber workmanship.
- f. Sydney Water will not be held liable, nor its directors, officers, and employees, for any loss, damage, expense and liability resulting from the loss, destruction or damage of property arising out of or in any way connected with the installation or operation of the toilet suite. The applicant(s) agrees that they will indemnify and keep indemnified Sydney Water from any claim or liability arising out of, or in relation to the toilet suite that is the subject of the rebate application to the extent that any claim or liability is not caused by Sydney Water's negligence or breach of the application or any other term implied by law.
- g. You will be required to repay the rebate if any of these terms and conditions are found to have been breached
- h. Sydney Water reserves the right, at its sole and absolute discretion and at any time, to change any or all of the terms and conditions for the rebate program or to cancel the rebate program before 30 June 2011.
